

#### **Summary:**

This plan is primarily aimed at ensuring all health safety conditions for customers and employees in strict compliance with the current legal norms and standards related to certifications assigned to BBDouro in response to the pandemic caused by "COVID-19".

It also contains a set of actions and procedures that, not being explicitly enshrined in any of the aforementioned rules, will be adopted by BBDouro as it considers it to be an added safety factor.

In view of the permanent evolution of the situation, both from a scientific and legal point of view, this plan will naturally be subject to updates that follow the evolution of the situation, which updates will always be communicated in a timely manner.

For the elaboration of this plan, we had the collaboration of the Lusíadas Saúde Group. This plan was developed based on standards and knowledge as of May 11th, 2020 and updated on September 2nd 2020.

### **Actions and procedures:**

- 1. Outdoor meeting point is next to "Boat Access Gate" in a wide space respecting the rules of social distancing (Waiting Area - attached map).
- 2. Personal belongings will be placed by the Skippers inside the vessel or in a space for this purpose.
- 3. Belongings whose participants do not want to take on board will be placed in washed and disinfected bags and taken by the respective Skippers to a space intended for that purpose.
- 4. Disinfection of hands before and after the tour / trial is mandatory. All Skippers will have alcohol-gel packs in their possession, which can be requested throughout the activity. There are several disinfection points in the area (1).
- 5. The use of face mask is optional for private groups. For non-exclusive tours / trials, the use of a face mask is mandatory. 3-layered surgical masks can be provided in a specific point (2).
- 6. It is mandatory o disinfect shoes immediatly before entering the boats. A disinfection mat (4) based on diluted sodium hypochlorite will be installed in the boarding / landing area.













## **CONTINGENCY PLAN COVID-19** BBDOURO - SAILING TOURS

- Boarding / landing will be carried out gradually in order to avoid a higher density than desirable in the embarkation / disembarkation area.
- 8. After arriving ashore, the used life jackets must be given to the respective Skippers for placement in a specially designated place and later sent to the disinfection area.
- 9. Access to the interior area of the vesse lis limited to the use of bathroom. All other accesses are only allowed to crew members.
- 10. After use, disposable face masks must be deposited by their owner in a place specifically designated for this purpose (4).
- 11. After the activity, the boat will be washed with and sensitive areas will be disinfected.


